



ORDER

Consequent upon extension of National Rural Employment Guarantee Act, 2005 to the State of Jammu & Kashmir vide notification dated 12.5.2007, the districts of Doda, Kupwara, Poonch, Anantnag and Jammu were notified for coverage under NREGA with effect from 6.6.2007 vide Notification No. 28012/10/2005-NREGA dated 4.6.07. All the remaining districts in the States were covered under NREGA with effect from 1.4.2008. The 8 districts, namely, Samba, Ramban, Kishtwar, Reasi, Ganderbal, Kulgam, Shopian, Bandipora which have been carved out of the original districts in the State of Jammu & Kashmir were part of these districts and NREGA is under implementation in all the rural areas of newly created districts with effect from the date from which the original districts had been notified for coverage under the Act. However, for the purpose of release of funds to these newly created districts for implementation of NREGA, the Central Government identifies the following districts as independent NREGA districts :-



ORDER

Consequent upon enactment of National Rural Employment Guarantee Act, 2005 on 5.9.2005, 20 districts in the State of Jharkhand had been notified for coverage under the Act with effect from 2.2.2006 vide Notification No.28012/10/2005-NREGA dated 24.1.2006. The two remaining districts of the State were notified for coverage under NREGA with effect from 1.4.2007 vide notification dated 26.3.2007. Ramgarh and Khunti districts have been created by the State Government of Jharkhand by reorganizing the boundaries of Hazaribagh and Ranchi districts respectively vide Notifications dated 12.9.2007. The newly created districts were parts of Hazaribagh and Ranchi districts when NREGA was launched in these districts with effect from 2.2.2006. NREGA is under implementation in all the rural areas of both the newly created districts. However, for the purpose of release funds to these newly created districts for implementation of NREG Act, the Central Government identifies the following districts as independent NREGA districts :-
