Sub: MGNREGS –Direct Benefit Transfer (DBT) implementation by 31st December, 2016- Regarding.

Sir/Madam,

As you are aware Government has fixed **31**st **December, 2016** for completion of DBT implementation under MGNREGA with regard to Aadhaar seeding in the programme database and making Aadhaar Based payments (ABP) to all the active workers.

- (2) Accordingly, the Ministry has been regularly reviewing the DBT implementation in the PRC meetings, monthly State MIS Nodal Officer meetings, Video conference on 16th May, 3rd June, 17th June, 8th August, 8th September, 06th October and 15th November, 2016. As of now the status of DBT implementation at the National level is as follows: -
 - Total Active workers: 10.88 Crore
 - Aadhaar Seeding into NREGASoft: 8.45 Crore [78%]
 - Aadhaar Based Payments enabled: 3.57 Crore [33%]
- (3) In order to expedite DBT implementation in your state it is requested to take necessary steps to complete the following:
 - a) Complete the Aadhaar seeding in the NREGASoft of all Active workers [15th December, 2016]
 - b) <u>Co-ordinate with the Banks</u> and share the Aadhaar consent forms with them to get the Aadhaar numbers seeded in the Bank database and mapping at the NPCI mapper by the banks [15th December, 2016].
 - c) <u>Programme Officer (PO) Verification</u>: It is observed that there are Aadhaar numbers which are pending for cross verification by the PO. This may be checked on daily basis and the backlog may be cleared (Ref: NREGASoft report R1.1.6). **[On daily basis]**
 - d) Conversion of the joint account into individual accounts of the workers.

(4) You are requested to kindly review the status of DBT implementation (enclosed) in your state and take appropriate measures to expedite and meet the DBT implementation timelines.
